1. HUMAN RIGHTS AND WORKERS' RIGHTS

Lomopress pays the utmost attention to the respect of human and workers' rights in the supply chain and requires its suppliers the same commitment.

Lomopress suppliers are also encouraged to initiate diversity, equity and inclusion practices as well as implement concrete initiatives against all forms of abuse, harassment or discrimination.

In particular, Lomopress suppliers commitment themselves to:

- **Ensure health and safety of workers at work**, by adopting affective measures to prevent accidents at the workplace and promoting the well-being;
- **Promote equal opportunities and inclusion**, by avoiding any type of discrimination at the workplace;
- **Prevent and counter all forms of harassment in the workplace**, by promoting a safe and respectful environment for all workers;
- **Comply with child labor regulations**, by avoiding the hiring of minors who do not meet the minimum legal age established by the laws of the countries in which they operate;
- **Ensure that the work is contracted with contracts** compliant with current regulations and that employees are free to terminate the employment relationship;
- **observe the laws in force regarding the economic treatment of workers;;**

2. ENVIRONMENT AND SUSTAINABILITY

Lomopress supports sustainable growth, committed to reducing the impact on the environment and promoting shared responsibility across the supply chain.

Suppliers must comply with environmental regulations and adopt responsible behavior regarding:

- **Management of the environmental impacts** resulting from its activities, including waste management, emissions into the atmosphere, water discharges and the possible use of toxic and/or hazardous substances;
- **Adoption of environmental practices** to reduce the Carbon Footprint of the products and/or services offered;;
- **Transparent sharing of environmental and energy data**, useful for example in measuring and monitoring climate-altering gas (GHG) emissions

For this reason, Lomopress suppliers are committed to:

- avoid situations of both actual and potential conflicts of interest, which could compromise the integrity of commercial relations;
- adopting fair business practices in acquiring new customers and in the management of business partners relationship;
- operate in accordance with applicable export regulations and conduct necessary third-party due diligence to prevent any involvement in illicit activities.

4. INFORMATION SECURITY AND PROTECTION OF PERSONAL DATA (PRIVACY)

Lomopress observes all applicable laws and regulations in the handling of personal information, recognizing the need for privacy protection in business operations. Lomopress considers cybersecurity and data protection central elements in its operations, including collaborations with external partners.

Partners are required to process all sensitive information, including business, technical, financial, personal data, know-how and trade secrets, maintaining confidentiality, availability and integrity, and avoiding unauthorized disclosures, in compliance with current regulations.

To further strengthen data protection and the security of its information, Lomopress adopts a management system that complies with internationally recognized standards, such as TISAX (Trusted Information Security Assessment Exchange).

Supplier are required to


- fully comply with local and international laws on the protection of personal data;
- take appropriate measures to ensure data security
- refrain from selling, disclosing and using the data for purposes not expressly authorized by Lomopress;
- anonymize data according to required regulatory standards;
- promptly report to Lomopress any violation, suspected incident or compromise of personal data processed on behalf of Lomopress

5. MONITORING, CHECKS AND IMPROVEMENT

Lomopress is committed to ensuring that the principles contained in this Supplier Code of Conduct are understood, applied and adhered to throughout the supply chain.

For this purpose Lomopress has foreseen a revision and check process which includes the following activities:

- **Periodic monitoring:** Lomopress reserves the right to verify supplier compliance through audits, documentation collection, self-assessment questionnaires and, where necessary, on-site visits.
- **Management of non-conformities:** in case of violations to the Code, Lomopress can request the supplier to adopt a corrective action plan with time and methods agreed.
 - Missing failure to adjust may result in suspension or termination of collaboration.
